Release and Waiver: Volunteer does hereby release and forever discharge and hold harmless Toys for Kids, Inc. and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Toys for Kids, Inc.

Volunteer understands that this release discharges Toys for Kids, Inc. from any liability or claim that the Volunteer may have against Toys for Kids, Inc. with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's activity with Toys for Kids, Inc., whether caused by the negligence of Toys for Kids, Inc. or its officers, directors, employees, agents or otherwise.
